## 4. New Business: Presentation by Ken Bauer of Solalex Energy

- Ken Bauer presented Solaflex Energy's solar EV charger.
- Key points of the presentation:
  - o Off-grid EV charger, no digging, trenching, or permitting required.
  - o Installation can be completed in one day.
  - Lease option available at \$4000 annually, including service and maintenance.

- Purchase option available at \$35,000 after federal tax credit.
- Suitable for workplace or long-duration daytime charging.
- Case study at Dartmouth College showing successful implementation.

## 5. Discussion on Solar EV Chargers

- Ward raised concerns about the utility of the solar EV charger in Winhall, given the small number of potential users.
- Andrea suggested considering other locations like the Winhall Arts Center or library.
- Discussion on the potential for businesses and institutions like Burr and Burton Academy, Stratton Resort, and local hospitals to benefit from the technology.
- Mike suggested introducing Ken to other town energy committees and large employers in the area.

### 6. Next Steps and Action Items

- Mike to follow up with Ken Bauer and introduce him to other town energy committees and potential large employers.
- Andrea to draft and distribute minutes from this meeting.
- Consideration of alternative solar solutions for Winhall, such as grid-tied solar panels.
