Request for Proposals ~ Highway Department Truck

The Town of Winhall is seeking proposals on a new plow truck for the Highway Department.

This Request for Proposals addresses the following:

- Color dark jade metallic or comparable
- Minimum 500 hp motor
- 30,000 pound rear end
- 20,000 pound front end (Easy Trac)
- Air brakes
- 4500 Allison automatic transmission with PTO provision and T-handle shifter mounted to the arm rest
- Power and heated mirrors; fender mirrors; extra large rear window
- Deluxe comfort cab interior and seat; dual arm rests; air conditioning; tilt and telescopic steering wheel
- All-wheel drive

Body and plow specs:

- 10 foot all angle highway plow; 10 foot wing; quick locks for plow
- Grab handles outside of the cab
- Heated LED plow lights with diverter switch
- Stainless oil tank and stainless hydraulic lines
- Fuel tank on driver side (80 gallon preferred)
- Armrest joystick-actuated implement controls
- 3 LED heated spotlights and 3 LED heated spotlights with cameras (6 total)
- 10' dump body with inner dump; AR450 steel body with poly slide hydraulic-feed door; Pintle plate with 2" receiver; LED strobe lights (cab mount and corners of body); LED heated tail lights; Electric tarp; Dual function ground speed electric sander controls; All grease fittings remote located.
- \Rightarrow Looking to trade a 2018 All-Wheel Drive Western Star 4800 with estimated 52,000 miles.

- 1) A description of each vehicle available with full specifications and pricing of all options above.
- 2) Website links or photographs of vehicles, and any other applicable information.

The Town of Winhall is looking to purchase this vehicle in the Spring of 2025.
